Annotated Bibliography on Technology

An annotated bibliography (also known as a bibliographical essay or a literature survey) is an outline and evaluation of past exploration on a topic. It is often assigned as an assessment task before writing an exposition or examination paper to encourage students to survey and NR 621 Literature review about what has already been discovered.

NR 621 Literature Review

A literature review is a type of research paper in which you examine previous research on a specific topic and present your findings. It is a common assignment in many college courses and helps students understand the importance of scholarly work.

For this NR 621 assignment, you will be identifying a problem that could benefit from an interdisciplinary arrangement proposition (Assessment 2). You will start laying the foundation for your literature review by researching potential change hypotheses and initiative procedures that nr500.10532.week3 addressing bias It be useful in addressing your identified issue.

You will also be examining articles that are relevant to your inquiry topic and question, using the chart format provided in class to systematically record and evaluate information. As you read, you will make connections between the information you find and your inquiry question. This will help you build upon knowledge that already exists about your topic and will also reveal gaps in research that you can investigate further.

NR 500 Week 3 Addressing Bias

A literature review is a critical component of any research project. It helps you identify what work has already been done on your topic and connects you to a continuous scholarly discussion that spans many disciplines, decades and subject areas. It can also help you discover gaps in NRS 493 Literature Review that your research may fill.

For this assignment, you will login to both FierceEMR and/or FierceHealthIT and select a topic that addresses the issue of bias in healthcare. You will then write a professional, scholarly prepared paper that discusses your rationale for selecting the topic and cites pros and cons as it relates to nursing practice. The assignment is due in the course drop box by Sunday at 11:59 PM MT.

NR 493 Literature Review

The NR 493 Literature Review allows learners to develop an intrinsic understanding

of their chosen research topic, prominent researchers in the field and the relevant trends and theories. It also helps to connect them with future research "peers" and gives them a reason to conduct their own investigation.

This week's annotated bibliography on <u>nurs fpx 4010 assessment 2 interview and interdisciplinary issue</u> focuses on the use of telehealth to improve patient outcomes in healthcare settings. The resources include articles, scholarly journals and government reports on the effectiveness of this approach. The articles range from those examining the impact of telehealth on patients' health outcomes to those looking at the cost-effectiveness of this approach.

Unconscious biases are often hidden in the decision-making process, but they can affect everything from hiring decisions to client interactions. One way to address them is through a training program that involves using recordings of real-world situations.

In this assessment, you will begin laying the foundation for your interdisciplinary arrangement proposition (Assessment 3). You will identify a problem and its cause from the PICOT question you identified in Assessment 2. Then you will investigate potential change hypotheses and <u>nurs fpx4040 assessment 3 annotated bibliography on technology</u> procedures that could be applied to address the issue. You will use the chart format provided in class to systematically record and evaluate information from the literature you read.
